GENERAL COMMENTS

The FOB Gulf DDGS to SBM spread for this week was \$104, down from \$106 last week. The FOB Gulf DDGS to corn spread is \$41.46, up from \$33.28 last week. Ethanol production in the United States averaged 1.119 million barrels per day in the week ending Jan. 16, down 77,000 bpd versus the prior week and 12,000 bpd, or 1.1%, higher than in the same week last year.


